#### **Academic Integrity:**

## **Course Description:**

This English Language Arts course for tenth grade is devoted to an academic study of American literature from the colonial period to the late twentieth century. Because much of the early literature is nonfiction (diaries, letters, sermons, almanacs, speeches, and foundational documents), there are many opportunities to analyze historical and informational texts. Students come to see the fluid relationship between fiction and nonfiction: for instance, the literary tropes in Jonathan Edwards's "Sinners in the Hands of an Angry God," or the dual historical contexts of Arthur Miller's *The Crucible*. In seminars, students discuss questions such as "Does Anne Bradstreet's work typify or differ from the other Puritan literature that you have read?" Throughout the semester, students have opportunities to make connections with history, art, and other subjects. Essays range from the analytical to the creative. Students will have the opportunity to write a narrative essay in the style of Thoreau's *Walden* or compare the treatment of a given theme in works from different genres. Students build on their writing skills from previous years, integrating multiple sources and perspectives into their work, reading literary criticism, and writing longer and more complex essays. To reflect the increasing importance of graphics and visual images in texts published in print and electronic media, students are asked to analyze how such images both relate to written texts and serve as alternative forms of text themselves. By the end of the semester, students have a foundation in American literature and are ready to branch out into other cultural representations of literature.
